COURSE SUBSTITUTIONS AND WAIVERS

PURPOSE

To minimize the need to complete Curriculum Review Forms (CRFs) and to provide academic advisors with authorization to sign Individual Curriculum Adjustment Forms (ICAFs), this document outlines exceptions that can be authorized by academic advisors. If a course is listed in the table below as an acceptable substitute/waiver, a CRF will not need to be completed. In addition, academic advisors are authorized to sign the ICAF without the need for further authorization from the Assistant Dean of Graduate Affairs or other designated Faculty Chairs.

POLICY & PROCEDURE

CRFS

CRFs will only be submitted to the Assistant Dean or appropriate Faculty Chair in the following instances:

• Request for Eight Year Time Limit Extension

- Request for Reinstatement (students returning from suspension) to an HCBE Program (form to be submitted to Associate Director of Enrollment Services)
- Upon Readmission (students returning after more than one year of inactivity) for students whose academic plan will require more than eight years for program completion

If the course is not listed in the table above, a CRF may be submitted for further consideration of substitutions or waivers.

ICAFS

COURSE SUBSTITUTIONS, WAIVERS AND TIME LIMIT

An Individual Curriculum Adjustment Form (ICAF) will need to be completed in one of two ways to reflect course completion:

- Substitution A substitution request will be made in the following instances:
 - o if a student has completed the course however the course is not a part of an earned degree
 - o if the class is part of a certificate program
 - Classes with GMP prefix for which a 8 year time limit extension has been granted
- Waiver if a student has completed the course as part of a degree issued by NSU, the ICAF will be completed to waive the requirement form the student's curriculum (and reduce the total number of credit hours required to complete the degree).
- Time Limit Advisors may sign off on time limit extension as indicated above under the section titled CRFs.

ADVISOR AUTHORIZATION FOR ICAFS

If an email is obtained from the Assistant Dean or appropriate Faculty Chair, the message will be copied into SPACMNT and the Academic Advisor is authorized to sign the form for the adjustment to the student's CAPP.

DUAL DEGREES

In cases of dual degree programs (e.g., JD/MBA), the courses listed per degree program in the Dual Degrees section of the HCBE graduate catalog will be waived from the curriculum upon the point of admission into the HCBE program. In order for the HCBE degree to be awarded, the student must first satisfy the degree requirements from his/her primary (e.g., non-HCBE) program. If the student does not satisfy the primary program curriculum requirements, then the waiver for the HCBE course-work will be rescinded and the student will need to successfully complete the HCBE classes and satisfy all other academic standards in order to have the HCBE degree conferred. Academic advisors are authorized to sign the ICAF for class waivers as stipulated in the graduate catalog. Students who have already completed a program with Law, Psychology, or Pharmacy will not have classes waived in the HCBE program. Both programs must be pursued at the same time in order for consideration to be granted for class waivers.
