GSCIS

- 2013-2014 Tuition (\$625/credit)
- 10% discount for MMIS classes
- Discounts differ by catalog
- Academic Calendar
 - Fall semester (XXXX20)
 - Winter semester (XXXX30)
 - Registration for Summer semester (XXXX50) NOT PERMITTED

SHSS

- 2013-2014 Tuition (unknown)
 - o 2012-2013 Tuition (\$605/credit)
- No discount for CARM classes
- Academic Calendar
 - Fall semester (XXXX20)
 - Winter semester (XXXX30)
 - Registration for Summer semester (XXXX50) NOT PERMITTED

Rate code maintenance

Spring and Summer Terms

- Rate codes applied to student account
- HSBE classes only
- Follow existing process for Corporate Partners, EdAssist partners, UG to Grad Alumni, 2nd Master's

Fall and Winter Terms

Fall term

- Remove rate codes
- GSCIS and SHSS classes start end of August
- HSBE classes start end of September

Winter term

- Remove rate codes
- GSCIS, SHSS, and HSBE classes start in January
- Inform student to pay balance due less anticipated discount in order to avoid late fee

Scenario 1:

GSCIS/SHSS Class Only – No HSBE Registration

Fall term – student will not receive financial aid Winter term – normal financial aid disbursement

Process for Verification:

- Confirm student not registered for HSBE after HSBE sequence II start
- SHSS class no discount
- GSCIS class review student catalog
 - 201310 or prior
 - Review account to determine if student is eligible for 10% discount (UG to Grad Alumni Award or HSBE Corporate Partner)
 - REFER TO TIP SHEETS FOR RATE CODE REQUEST
 - 201320 or after
 - Review account to determine if student is eligible for 10% discount (UG to Grad Alumni Award ONLY)
 - REFER TO TIP SHEETS FOR RATE CODE REQUEST

^{*} Inform student to pay balance due less anticipated discount in order to avoid late fee*

Scenario 2: HSBE Class Only

After HSBE sequence II start

- Review account to determine if student is eligible for discount
- Add HSBE rate code
 - ▼ If for fall term, be sure to remove rate code for winter term
 - ▼ If for winter term, rate code can remain on account

Scenario 3:

Registration for a Combination of HSBE and GSCIS/SHSS Courses

GSCIS/SHSS

- After HSBE sequence II start
- SHSS class no discount
- GSCIS class review student catalog
 - 201310 or prior
 - Review account to determine if student is eligible for 10% discount (UG to Grad Alumni Award or HSBE Corporate Partner)
 - REFER TO TIP SHEETS FOR RATE CODE REQUEST
 - 201320 or after
 - Review account to determine if student is eligible for 10% discount
 - UG to Grad Alumni Award ONLY
 - REFER TO TIP SHEETS FOR RATE CODE REQUEST

HSBE

- After HSBE sequence II start
- Review account to determine if student is eligible for discount
- Submit special rate code request to Administrator of Student Systems

Summary

- Spring and Summer terms (add rate codes) –
 business as usual
- Fall and Winter terms (remove rate codes) –
 accounts must be manually reviewed to determine if
 a student is eligible for a discount
 - SHSS classes receive no discount
 - GSCIS classes receive 10% discount (dependent upon catalog)
- Financial Aid is tied to HSBE academic terms
 - Fall term with no HSBE registration = no financial aid

Actions Taken

- On May 6, 2013 rate codes were removed from all active student accounts as of the fall 201420 term (MBA – BI/A and MBA – Conflict Resolution)
 - SPACMNT was noted accordingly
- Please review each account for the fall 201420 to determine if a discount will need to be applied

FYI

- Registration for Fall 2013 (201420) for GSCIS and SHSS began on May 6, 2013
- SHSS students able to self-register
- GSCIS students need MAJOR override for MMIS classes
 - As of May 6, the GSCIS Schedule of Classes is not listed yet
 - Effective Fall 2013, a fifth concentration course has been added (MGT 5090)

 - MMIS 0630 (Database Systems)
- Semester Two
 - MMIS 0642 (Database Warehousing)
- Semester Three
 - MMIS 0643 (Data Mining) QNT 5040 pre-req

 - MMIS 0692 (Capstone Project in BI)
- Effective catalog 201420 and forward student takes
 MGT 5090 whenever pre-reqs are satisfied

BI/A Course Planning Three Semesters (1 ½ years)

- Semester One
 - MMIS 0630 (Database Systems)
- Semester Two
 - MMIS 0642 (Database Warehousing)
 - MMIS 0643 (Data Mining) only if student has taken QNT 5040
- Semester Three
 - MMIS 0692 (Capstone Project in BI)
- Catalog 201420 and forward student takes MGT 5090 whenever pre-reqs are satisfied
